I/we further acknowledge that Casa Romana si Capela Inc. ("Casa Romana") and the Holy Resurrection Romanian Orthodox Parish ("Parish") have put in place preventative measures to reduce the spread of the Coronavirus/COVID-19.

I/we further acknowledge that Casa Romana and the Parish cannot guarantee that I/we will not become infected with the Coronavirus/Covid-19. I/we understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of me/us and others, including, but not limited to volunteers, contractors and employees of Casa Romana or the Parish, as well as other event attendees and their families.

I/we voluntarily seek to enter the property and/or attend events or services hosted by Casa Romana/or the Parish, and acknowledge that I/we am increasing my risk to exposure to the Coronavirus/COVID-19. I/we acknowledge that I/we must comply with all set procedures to reduce the spread while on the property.

I/we attest that:

- I/we am/are not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I/we have not traveled internationally within the last 14 days.
- I/we have not traveled to a highly impacted area within the United States of America in the last 14 days.
- I/we do not believe I/we have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- I/we have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by public health authorities.
- I/we am/are following all CDC and local recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I/we hereby release and agree to hold Casa Romana and the Parish harmless from, and waive on behalf of myself/ourselves, our heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to me/us and/or property that may be caused by any act, or failure to act of Casa Romana or the Parish, or that may otherwise arise in any way in connection with any events hosted by Casa Romana or the Parish. I/we understand that this release discharges Casa Romana and the Parish from any liability or claim that I/we, our heirs, or any personal representatives may have against Casa Romana or the Parish with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any events hosted by Casa Romana or the Parish. This liability waiver and release extends to Casa Romana and the Parish along with all their members, volunteers, and employees.
